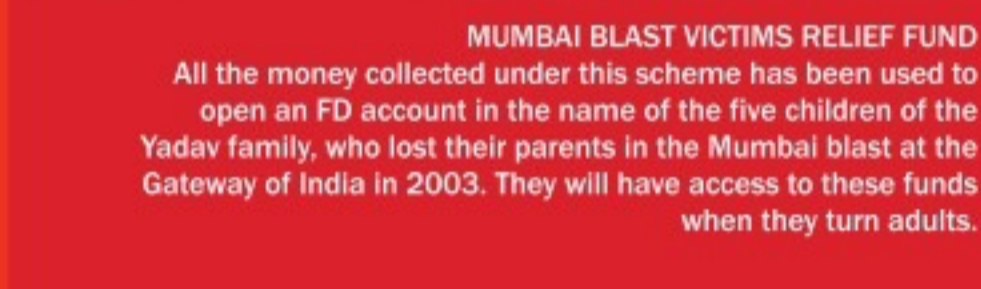

BIHAR FLOOD RELIEF FUND The funds have been used to build a multi-utility block in a Government School in village Lagma, district Saharsa.



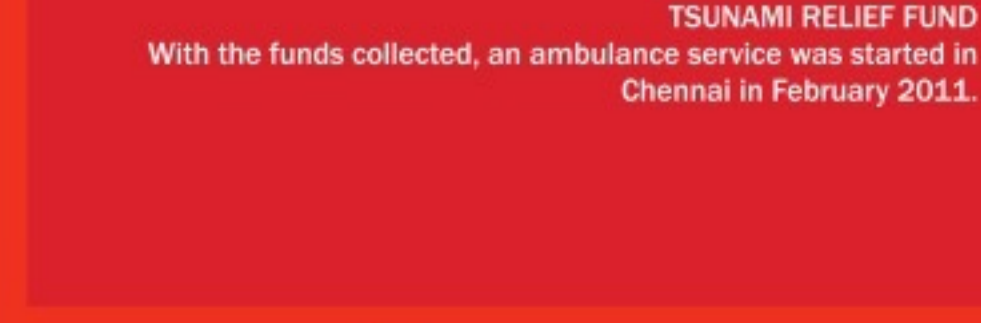
