

Ascendas Property Fund Trustee Pte Ltd appoints CEO

10 July 2014, Singapore – Further to the press release dated 24 April 2014, Ascendas Property Fund Trustee Pte Ltd (“**APFT**”), the Trustee-Manager of Ascendas India Trust (“**a-iTrust**”), wishes to announce the appointment of Mr Sanjeev Dasgupta as CEO with effect from 11 July 2014. Mr Dasgupta succeeds Mr Jonathan Yap, who will step down after having led a-iTrust since its listing in 2007.

Mr Dasgupta, who joined APFT on 15 January 2014, has extensive experience in corporate finance and fund management. His last role before joining APFT was President of Real Estate at ICICI Venture, where he was responsible for real estate private equity investments.

Its principal objective is owning income-producing real estate used primarily as business space in India. a-iTrust may also develop and acquire land or uncompleted developments primarily to be used as business space, with the objective of holding the properties upon completion. The portfolio comprises five world-class IT business parks in India, namely the International Tech Park Bangalore, International Tech Park Chennai, and CyberPearl, The V and aVance Business Hub in Hyderabad. a-iTrust is structured as a business trust, offering stable income distributions akin to a Real Estate Investment Trust. The Trust focuses on enhancing shareholder value by actively managing existing properties, developing vacant land in its portfolio, and acquiring new properties. The acquisition strategy includes a right of first refusal over substantially income-producing business space from Ascendas Land International Pte Ltd and Ascendas India Development Trust, as well as the acquisition of third-party properties across India. a-iTrust is managed by Ascendas Property Fund Trustee Pte Ltd, a subsidiary of the Ascendas Group.
