Temasek is filing this notification form to report a change in deemed interest from 24.00% to 23.99% in the Listed Issuer as a result of the disposal of 107,100 voting units by Islamic Bank of Asia.

Temasek's deemed interest in the units arises from the aggregation of interests of Ascendas-Singbridge Pte. Ltd. ("ASB") and DBS Group Holdings Ltd ("DBSH").

(A) Temasek's deemed interest via ASB 23.679%

- (i) ASB through its subsidiaries, Ascendas Land International Pte. Ltd. and Ascendas Property Fund Trustee Pte. Ltd., hold 23.679% of voting units.
- (ii) ASB is an indirect subsidiary of Temasek.

(B) Temasek's deemed interest through DBSH 0.312%

- (i) DBSH through its subsidiary, Islamic Bank of Asia holds 0.312% of voting units.
