Ascendas Property Fund Trustee Pte. Ltd., the Trustee-Manager of Ascendas India Trust ("a-iTrust" or the "Trust"), has reported the results of a-iTrust for the financial year and fourth quarter ended 31 March 2016 ("FY15/16" & "4Q FY15/16").

Mr Sanjeev Dasgupta, Chief Executive Officer said, "Ascendas India Trust's FY15/16 DPU at 5.50 Singapore cents, is 13% higher than the previous year. Positive rental reversions, higher portfolio occupancy, and new acquisitions contributed to our robust income growth."

Financial performance (FY15/16 vs FY14/15)

In Indian Rupee terms, FY15/16 revenue grew by 11% to ₹6.8 billion, supported by rental income from CyberVale and aVance Building 3 and higher portfolio rental and occupancy levels. Total property expenses were largely stable at ₹2.4 billion as lower utilities expenses from a reduction in fuel rates were offset by the increase in expenses arising from the newly acquired properties. This was a key reason for the 20% growth in the FY15/16 net property income which stood at ₹4.4 billion.

In Singapore Dollar terms, FY15/16 DPU increased by 13% to 5.50 SC.

Portfolio performance & balance sheet

a-iTrust's committed portfolio occupancy remained healthy at 96%.

a-iTrust's gearing ratio was 26% as at 31 March 2016. a-iTrust had total effective borrowings of \$\$345 million as at 31 March 2016. All of the Trust's borrowings are effectively on a fixed-interest rate basis. To reduce the Trust's exposure to currency risks, 73% of total borrowings were hedged into Indian Rupees.

Growth initiatives

Mr Dasgupta added "The Indian GDP grew by 7.3% in 2015⁵, making India the fastest growing major economy in the world. Ascendas India Trust is well positioned to capture increased demand from tenants for quality business space by developing its land banks and acquiring new properties."

In Bangalore, the construction of the 620,000 sq ft Victor building is expected to be completed by June 2016. 100% of the building has been preleased to existing and new tenants.

At The V in Hyderabad, a-iTrust is developing a 408,000 sq ft multi-tenanted building to cater to expansion demand from existing tenants. While the building is only scheduled for completion in the latter part of 2017, it has attained 17% leasing commitment to date. In Pune, a-iTrust has invested ₹2.6 billion (S\$57 million⁶) in a 1.52 million sq ft property named BlueRidge 2. The Trust expects to complete the acquisition of BlueRidge 2 by December 2016. Entering the Pune market will allow a-iTrust to better serve its existing and new tenants.
