CapitaLand Limited ("CL") is deemed interested in the 239,896,743 units in a-iTrust comprising (i) 56,617,355 units in a-iTrust held by Ascendas Property Fund Trustee Pte. Ltd., a wholly-owned subsidiary of Ascendas Investment Pte Ltd (which is in turn a wholly-owned subsidiary of Ascendas Pte Ltd (which is in turn a wholly-owned subsidiary of CL)) and (ii) 183,279,388 units in a-iTrust held by Ascendas Land International Pte Ltd. (a wholly-owned subsidiary of Ascendas Pte Ltd (which is in turn a wholly-owned subsidiary of CL)), by virtue of section 4(4) of the SFA.

CLA Real Estate Holdings Pte. Ltd. (f.k.a. Ascendas-Singbridge Pte. Ltd.) ("CLA") has a controlling interest in CL as it holds more than 50% of the voting shares of CL. CLA is therefore deemed, pursuant to section 4(4) of the SFA, to have an interest in the 239,896,743 units in a-iTrust in which CL is deemed to have an interest.
