## DISCLOSURE PURSUANT TO RULE 704(31) OF THE LISTING MANUAL OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited, Ascendas Property Fund Trustee Pte. Ltd. (the "Trustee-Manager" or "APFT") (in its capacity as Trustee-Manager for Ascendas India Trust ("a-iTrust", or the "Borrower") wishes to announce that APFT has secured a S\$100 million term loan facility from The United Overseas Bank Limited (the "Facility"), and that under the Facility, it is an event of default if CapitaLand Limited does not continue to own directly or indirectly, through any wholly-owned subsidiaries, at least 51 per cent of the issued share capital of the Trustee-Manager and if a-iTrust is terminated pursuant to the provision of the Trust Deed.

If such an event occurs and APFT fails to pay the outstanding amounts due and payable under the Facility, it may trigger cross defaults under other facilities, debt issues and borrowings of a-iTrust and/or its subsidiaries (collectively, together with the amount owing under the Facility, "Borrowings"). The aggregate level of Borrowings which are outstanding and that may be affected is approximately S\$778 million (excluding interest) as at 2 April 2020.

As at the date of this announcement, the event described above has not occurred.
