### ANNUAL GENERAL MEETING TO BE HELD ON 12 APRIL 2021

---

1. **Background:** Ascendas Property Fund Trustee Pte. Ltd., the trustee-manager of Ascendas India Trust (“a-iTrust”, and the trustee-manager of a-iTrust, the “Trustee-Manager”), refers to:
  - (i) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
  - (ii) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the “Order”) which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of business trusts.
  
2. **Date, time and conduct of Annual General Meeting:** The Trustee-Manager wishes to announce that pursuant to the Order, the Annual General Meeting of a-iTrust (the “AGM”) will be convened and held by way of electronic means, on Monday, 12 April 2021 at 2.30 p.m. (Singapore Time).

The Trustee-Manager’s Chairman, Mr Chiang Chie Foo, and Chief Executive Officer, Mr Sanjeev Dasgupta, will conduct the proceedings of the AGM and address, prior to the AGM, substantial and relevant questions which holders of units in a-iTrust (“Units” and the holders of Units, the “Unitholders”) have submitted in advance.
  
3. **Notice of AGM and proxy form:** The Notice of AGM and proxy form have been sent to Unitholders solely by electronic means via publication on a-iTrust’s website at the URL <https://ir.a-itrust.com/agm.html>, and has also been made available on the Singapore Exchange Securities Trading Limited (the “SGX-ST”) website at the URL <https://www.sgx.com/securities/company-announcements>. Printed copies of these documents will not be sent to Unitholders.
  
4. **No personal attendance at AGM:** Due to the current COVID-19 situation in Singapore, **Unitholders will not be able to attend the AGM in person.**
  
5. **Alternative arrangements for participation at the AGM:** Unitholders may participate at the AGM by:
  - (i) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (ii) submitting questions in advance of the AGM; and
  - (iii) appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM.

Alternative arrangements relating to attendance at the AGM via electronic means (including arrangements by which the meeting can be electronically accessed via live audio-visual webcast or live audio-only stream), submission of questions to the Chairman of the AGM in advance of the AGM, addressing of substantial and relevant questions prior to the AGM and voting by appointing the Chairman of the AGM as proxy at the AGM, are set out in the Notice of AGM.

<b>2.30 p.m. on 10 April 2021 (Saturday)</b>	Deadline for Unitholders to submit proxy forms.
<b>2.30 p.m. on 11 April 2021 (Sunday)</b>	Authenticated Unitholders and CPF and SRS investors will receive an email which will contain user ID and password details, as well as instructions on how to access the live audio-visual webcast and a toll-free telephone number to access the live audio-only stream of the AGM proceedings (the " <b>Confirmation Email</b> ").  Unitholders and CPF and SRS investors who do not receive the Confirmation Email by 2.30 p.m. on 11 April 2021, but have registered by the 9 April 2021 deadline should contact a-iTrust's Unit Registrar, Boardroom Corporate & Advisory Services Pte.
