Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited, Ascendas Property Fund Trustee Pte. Ltd. (the “**Trustee-Manager**” or “**APFT**”) (in its capacity as Trustee-Manager for Ascendas India Trust (“**a-iTrust**”)) wishes to announce that APFT, as Trustee-Manager of a-iTrust, has secured a S\$100 million term loan facility from The United Overseas Bank Limited, through a Facility Agreement executed on 13 April 2021 (the “**Facility Agreement**”), and that under the Facility Agreement, it would be an event of default if CapitaLand Investment Management Limited does not continue to own directly or indirectly, through any wholly-owned subsidiaries, at least 51 per cent. of the issued share capital of the Trustee-Manager and/or if a-iTrust is terminated pursuant to the provisions of the Trust Deed.

If any of the aforesaid events occur and APFT fails to pay the outstanding amounts due and payable under the Facility Agreement, it may trigger cross defaults under other facilities, debt issues and borrowings of a-iTrust and/or its subsidiaries (collectively, together with the amount owing under the Facility, “**Borrowings**”). The aggregate level of Borrowings which are outstanding and that may be affected is approximately S\$974 million (excluding interest) as at 13 April 2021.

As at the date of this announcement, the events described above have not occurred.
